### Further information

The results of animal experiments using pigments of this type indicate no toxicologically relevant properties. Since the substance is poorly absorbed, no hazardous properties are to be anticipated. Inhalation of the dusts should be avoided as even inert dusts may impair respiratory organ functions. The individual test results were as follows: skin tolerance (rabbit): no irritant effect; eye irritation test (rabbit): no irritant effect; sensitization test (guinea pig): no sensitizing potential. LD<sub>50</sub>(oral, rat): not determinable; all animals still alive after 15,000 mg/kg. Subchronic toxicity (rat): no appreciable findings up to 50 000 ppm.
